

PARTICIPANT REGISTRATION FORM

I am an applicant for a trip provided by LSTours LLC (hereinafter referred to as "LS") or I am a legal guardian of a minor under the age of 18 who is participating. By signing this application, I understand and agree to the following:

I understand that my tour begins and ends as set out in the Travel Agreement.

I understand that the trip price presented to me by the group leader is based upon a minimum number of paying participants (unless otherwise noted) and the group's failure to meet such minimum number of paying participants may necessitate changes to the trip package price.

I understand that it is my responsibility to secure the necessary travel documents (passport and or country visa[s]). Failure to do so does not constitute grounds for a refund.

I understand that the authorized representative for my group has signed and agreed to the Terms and Conditions of travel with LS. I am agreeing to the Terms and Conditions provided by LS. I also understand that I am held to the same Terms as it applies to me, including but not limited to the conditions surrounding the voluntary cancelation of my participation in the tour as detailed in the Cancelation Policy. I will rely on my group leader to explain the terms & Conditions and will contact them regarding any issues, but not limited to, any questions regarding any refunds for any reason. Unless otherwise stated by LS, refunds will come through the group leader and will not be paid directly from LS.

I understand that this and all agreements shall be governed in all respects, and shall be judged, by the laws of Missouri. In the event of any claim or dispute arising out of my relationship with LS, arises between the Released Parties (as listed in the last paragraph in this agreement), the parties submit and agree to the exclusive jurisdiction and venue of the courts of the Missouri and of the united States District Court for the Eastern District of Missouri.

I understand that if an additional fee or cost is imposed by a service provider, including any fuel surcharges, baggage fees, and etc arise after the contract for your trip has been authorized, LS reserves the right to pass along to myself and the group any and all fees.

I agree to abide by all local laws when traveling abroad, including local laws concerning drugs and alcohol. (Minors must have parents' permission to use alcohol even if the local law would otherwise permit them to.) I understand that if I violate any local laws, even unintentionally, I waive my right to any refund. I also understand that if local authorities be involved, I will be subject to the laws of the country or province that I am visiting. I will abide by any and all rules and regulations of the facility in which I am being housed, or any attraction that I am visiting. In the event that I fail to abide by these rules and in turn causes me to be ejected from the facility or attraction, I will be responsible for securing alternate housing, any transportation and I will be responsible for all of the costs associated with alternate arrangements. If I am required or I request to return home ahead of schedule for any reason, or if I am unable to return with the remaining members of my group, I am responsible for securing any alternate transportation and am responsible for all cost associated with any alternate arrangements.

I understand and agree that if it is needed, LS has the right to make any adjustments to tour itineraries or to modify transportation arrangements,

including the use of substitute airlines or ground transportation. All attractions, events and transportation are based upon availability at the time of reservation.

I understand and agree that I am responsible to pay for any phone calls, incidentals, rentals or any other personal charges that I incur at the hotel. I am also responsible to pay for any damages that I cause to not only the hotels but also any attractions, transportation or any other property.

I understand that this agreement, LS's Terms & Conditions and LS's Travel Agreement represent the entire agreement between me and LS and I do not rely upon any oral statements made by my group leader, employees of LS or anyone else in relation to travel arrangements. This agreement can be amended by LS only in writing. Any waivers by LS of any terms of this Agreement will not affect any remaining provisions of this Agreement.

I understand that most pool facilities provided by Hotels do not provide a lifeguard and that any use of pool facilities will be at my own risk. Unless otherwise stated, night security is not included in your package.

I understand and agree that an air carrier's liability or a motor coach company's liability for loss of or any damage to baggage, property or for the death or injury to a person, is limited by their booking terms and conditions, any and all tariffs and or the Warsaw Convention.

I understand and agree that I have made the choice to travel with the group leader organizing my group trip and I understand and agree that this choice is not the responsibility of LS. Group leaders are not agents for, or employees of LS. The Released Parties as stated in the paragraph below shall not be liable for the actions, or non-actions, of the group leaders. I understand that a group leader is not provided to me or my group by LS.

I understand and agree to release and hold harmless the representative who has authorized the Travel Agreement, my Group Leader, the chaperones, LS and its affiliates (including parents, members, agents and employees of LS as well as LS itself) (the "Released Parties") from, and agree not to sue the Released Parties for, any claims that I may have arising from, or in connection with, any injury to myself, including bodily injury, mental anguish, emotional distress, my property or any other damage that I may suffer from any cause related in any way to my participation in an LS trip. Without limiting the generality of the forgoing, I agree not to sue the Released Parties for any personal injury, bodily injury, mental anguish, emotional distress, personal property or any other damage that I may suffer or incur from the Released Parties' negligence other than from intentional or reckless acts by such parties. I agree to release and hold harmless the Released Parties from any acts or omissions of any other agents over which the Released Parties have no indirect or direct control, including but without limitations, airlines, railways, bus companies, hotels, shipping companies, guides, tour directors, tour managers and any other sub-contracted agents or tour operators. I further agree to release and hold harmless the Released Parties from all acts of God, war (whether declared or undeclared), terrorist activities, incidents of politically motivated violence, illness or quarantine, strikes or government restrictions. This release also includes any and all activities not offered by LS that may be considered risky.

Sign your application only when you have read in full and understood the contents of this release agreement. This application must be signed and returned to LS, 90 days prior to travel or you will not be able to participate in the trip.
